1. Owner agrees to pay the rate of boarding per night beginning the day pet is checked into Cowboy Kennels INC. Owner agrees that the pet shall not leave Cowboy Kennels INC until all charges are paid in full by owner or specified owner's representative.
2. Owner further agrees to pay all costs and charges for special services requested, and all veterinary costs for the pet during the pets stay in the care of the Cowboy Kennels INC. If the pet becomes ill during boarding at Cowboy Kennels INC Dr. Kirlin will provide all necessary veterinary care unless specified by owner, said pet will be transported to the specified veterinary facility, and owner will be charged \$25.00 for transport of said pet.
3. Cowboy Kennels INC shall exercise reasonable care for the pet delivered by the owner to kennel for boarding. The Owner agrees to be solely responsible for any and all acts or behavior of said pet while it is in the care of the kennel.
4. Owner specifically ensures to the best of their knowledge that dogs have not been exposed to rabies, distemper, parvovirus, or kennel cough within a thirty-day period prior to boarding, and cats have not been exposed to feline upper respiratory infections, leukemia or rabies in last 30 days.
5. If said pet is abandoned by owner, Cowboy Kennels INC will notify owner in writing that said pet will be sold for fair market value. Owner will be liable for the balance of charges if the selling price does not cover all charges. If selling price exceeds these charges the balance will be returned to owner.
6. We will accept your bed and toys but we can not guarantee the return in same condition.
7. We assume every pet is flea free. However if we do notice fleas on your pet a Capstar tablet will be administered for \$4.50 per tablet. Owner initials _____
8. For best immunity response, Bordatella should be given at least one week prior to dog entering Cowboy Kennels. Otherwise owner understands said pet will not have optimal immunity. If the Bordatella vaccine is administered by Dr. Kirlin at time of boarding, owner understands said pet may experience kennel cough symptoms 6 to 8 days after vaccine has been given. Owner understands Cowboy Kennels is not liable for any veterinary care in reference to the Bordatella reaction. Owner Initials _____
